

Covenant Agreement

NAME:

This document is intended to provide general information regarding the guidelines and expectations of
Kingdom Boundaries Prison Aftercare (KBPA) and their housing entity known as <i>The Carpenter's Shop (TCS)</i>
and The Master's House (TMH) (417/413 S. Summit Ave. Sioux Falls SD 57104).
Please read each numbered paragraph and initial only after having a clear understanding of its content. If you
have any questions or concerns, please ask about it prior to signing. The purpose of this document is to provide
clarification for every resident, as well as the staff and volunteers affiliated with KBPA, about expectations
related to living at TCS or TMH.
KBPA will walk beside me and give advice about decisions but will not do the work for me. KBPA will provide
guidance for both my spiritual and physical needs. I understand that my choices will define my future. <u>I also</u>
understand KBPA owes me nothing. It is NOT KBPA's responsibility to bail me out of situations because
of my choices. I understand that there are consequences for my choices.
I understand making the transition into society will not be easy and that it will take time. To facilitate a positive
transition, I agree to spend a minimum of <u>ten weeks</u> at <i>TCS</i> and/or <i>TMH</i> .
I agree to participate in the KBPA Discipleship Program. This will include completing a personalized
discipleship/vision plan. Furthermore, I agree to weekly one-on-one meetings with the Discipleship Chaplain
while a resident at KBPA
I understand it is my responsibility to watch the TV monitors (each day) in the hallways in either The
Carpenter Shop or The Master's House. This is important so I can stay informed of what is going on at
KBPA and to see if there are any changes in policy affecting me. Also, each slide will have a number on it.
These numbers need to put on any bank withdrawal request to have your request considered

5. I agree to remain chemical/alcohol free. I will voluntarily participate in drug testing while I am a resident. I will

6.	I agree to not use tobacco products and/or E-cigarettes inside the <i>facility</i> .
	E-cigarettes and smoking inside TCS and TMH will result in being discharged from the program.
	(There is a designated smoking area at the rear of the building!)
	- No smoking is allowed in the front of the buildings.
	- After curfew, smoking is allowed ONE TIME per night in the rear of the buildings in full view of the
	cameras. This must happen only before 11 pm and after 5 am.
7	I understand that condice and incomes are both a fire hazard and leave seet on the wells and earling. Decayes of
/ .	I understand that candles and incense are both a fire hazard and leave soot on the walls and ceiling. Because of
	this I agree to not use candles or incense.
8.	I agree not to have weapons/knives on the property.
9.	I agree not to have any pets, including fish or snakes.
10.	I agree to pay rent in accordance with the lease agreement. I will pay in-full on the first of each month of my
	stay at KB. I also understand if detained, violated, re-incarcerated, or dismissed from the program that I will be
	responsible for all unpaid rent, and rent already paid will not be refunded or prorated
11.	I understand prior to my transition from KB to my own residence I will need my PO's permission. Also, I agree
	to give KB a minimum of two weeks' notice of my departure from KB with an exact date set for my move.
	Lastly, I understand I need to have saved a minimum of the first month's rent (and deposit and money needed
	for furniture) for my new place of residence before leaving KB.
12.	I agree to the following: a) to keep my apartment clean per KBPA staff standards, b) to do the daily and weekly
	chores assigned by KBPA staff, c) and keep the common areas clean and clutter free. For a more comprehensive
	and detailed list, see the "House Keeping Guidelines #009" document. I understand that I am required to
	assist with snow removal, lawn care, and general maintenance of the facility without reimbursement. (This is
	not an option.) I understand if I am unwilling to help with these duties that I will be charged a fine and my
	curfew could be restricted
13.	I agree to maintain good grooming and personal hygiene.
14.	I understand KBPA offers only limited transportation and <u>may not always be available</u> . Rides will be freely
	given within one week of release, when KBPA staff or volunteers are available. After one week, rides will be
	available and will be subject to a fee. These rides must be scheduled 24 hours in advance for work, treatment, or
	job interviews. I understand if I fail to plan and need a ride because of the failure to plan, I will be charged at

the rate of \$25.00/hour with a \$15.00 minimum. KBPA will assist resident in obtaining a bicycle and/or a bus pass. **I understand that I need to plan ahead**.

- 15. I understand there will be many worldly attractions for me to spend my time and money on. My top priority will be getting a job. I agree to turn in all income to KBPA. KBPA will deposit this money in a "Resident Account" and my personal fund balance will be available upon request. All funds will need KBPA's authorization and signature to be drawn out. In addition, I will keep a written bank register of my personal fund balance. (No banking privileges will be allowed if the band register is not maintained and kept in sync with the KBPA spreadsheet balance.) I will work on a budget. With this budget a plan will be made to pay for my needs first (rent, fines, restitution, PO, programing obligations, food, clothing, etc.). Second, I will formulate a plan to save for living independently (See paragraph#11). Third, when these obligations are met, money will be given to me for extras. I understand I need to distinguish my needs from my wants. If violated, detained, re-incarcerated or dismissed from TCS or TMH, my personal account balance will be used first to cover any unpaid rent or expenses before the balance is refunded or forwarded to a person or entity of my choice. I understand not turning in all income will lead to disciplinary action and may lead to termination.
- 16. I understand I can, with the permission of my PO and KPBA, open a personal bank account.
- 17. I understand a \$200.00 (TCS)/\$300.00 (TMS) rent deposit will be charged to my account. The deposit will be refunded when I leave if after a favorable walk-through inspection (personal area, the kitchen, and the bathroom) with a KBPA staff person has been done and I have done an exit interview. All rooms need to be clean and left in the same condition as when moving in. This will include that the bedding is freshly washed, and the bed is made. The refrigerator and freezer need to be cleaned out of all personal food, including leftovers, and washed. Also, all expenses (rent, food, utilities, etc.) need to have been paid. (*The deposit will be used to pay any and all unpaid expenses*.) The deposit will not be refunded if the apartment is left in an unsatisfactory condition requiring KBPA staff to clean and/or if resident is violated, detained, re-incarcerated or removed from the program.
- 18. I agree to the following hours [curfew]:
 - <u>9:00am 3:00pm</u> ----- Initial curfew until paperwork is completed and employment is secured (all interviews need signed form verifying appointment). In addition, social security card and birth certificate need to be on file (or evidence that they have been applied for).
 - <u>6:00 am 8:00 pm -----</u> After employment has been verified, have worked a day, finished Vision Plan, and personal space is maintained per the house cleaning document.
 - <u>6:00 am 9:00 pm -----</u> After a financial work sheet is completed and approved by KBPA staff, and income starts to be deposited in the resident account.

	insurance lapses, I will lose my right to drive and KBPA staff must be notified immediately
30.	I understand that I am responsible for my own food. KBPA will advise about the process of obtaining food
	stamps, but every attempt must be made in securing a job. (Food stamps are to be used temporarily and for food
	items only.) KBPA will not let anyone go hungry and will make every attempt to help you make good food
	choices. Each resident is responsible to buy and prepare their own food.
31.	I agree to use ear buds at appropriate times (for radios, stereos, video games, and televisions). Video games will
	be allowed after a job has been secured and approved by staff. Video games must be connected to a personal
	(KBPA approved) flat screen TV or monitor. KBPA will provide one TV with a digital antenna; no cable is
	provided or allowed in the TCS. I understand personal computers and telephones are subject to scanning for
	inappropriate material. Personal computers and cellphones cannot be loaned out or borrowed and must be
	password protected. For a more comprehensive and detailed list of allowed movies and video games, see the
	"Limit on personal items #063" document.
32.	I agree to handle all conflicts, such as physical violence, threats, emotional abuse, stealing, or foul language

55. I understand I CS and I MS have camera surventance and a door monitoring system. Both the cameras and door
systems are monitored by KBPA staff. The camera archives and personal door logs will be and are available for
review by the PO, if requested. Any attempt to interfere with surveillance and/or door security (this includes
physical tampering of equipment, blocking camera views, misusing FOBS, and exiting/entering buildings
through windows) could result in immediate communication with PO and could lead to immediate dismissal
from the program
34. I understand there is limited room in the apartments and personal property will be kept to a minimum. All
personal property will need to be approved by KBPA staff and recorded on a personal inventory worksheet. I
have read, understand, and agreed to. See the "Limit on personal items #063" document.
35. I agree KBPA will not be responsible for personal property that is lost, broken, or stolen
36. I understand in the event of detainment, violation, re-incarceration or removed from the program, personal
property will be collected. KBPA has the right to use personal property to cover any financial obligations. After
financial obligations have been meet, property will be given to a prearranged entity. If after one-week personal
property is not claimed, it will be considered a "donation" to the ministry.
37. I understand important paperwork (birth certificates, SS cards, legal paperwork. etc.) can be stored in my
personal file in the KBPA office in a secured area. KBPA will not be responsible for such paperwork if not in
KBPA possession.
38. I agree that if dismissed from <i>TCS or TMH</i> for ignoring and/or violating any portion of this covenant
agreement, or detained, violated, or re-incarcerated, my person property and the balance of my funds in the
resident account belonging to me will be held and used for unpaid rent, food, and other expenses acquired while
living at <i>TCS or TMH</i> before my bank balance is refunded.
39. I understand that this "Covenant Agreement" is a fluid document and is not all inclusive , but is specific in
spirit, as well as guiding points to the basic expectation of KBPA. I understand that this document can be
revised any time a situation warrants it. Document with revisions can and will supersede any and all
previous dated documents. I also understand that violations of this "Covenant Agreement", or other
conflicting behavior may be cause for discharge from <i>TCS</i> and/or <i>TMH</i> .
40. DISPUTE RESOLUTION: Any disagreement which may arise out of this Agreement shall be submitted to
arbitration and shall be enforceable under the Uniform Arbitration act, as Amended by South Dakota Law.
Judgement on the award shall be entered into by any court of competent jurisdiction, and the decision of the
arbitrator shall be a condition precedent to legal rights. The losing party shall pay both parties' attorneys' fees,
